### ADOPTION AGREEMENT

This agreement is made as of \_\_\_\_\_ between Shamrock Farm, LLC and \_\_\_\_\_ (hereinafter referred to as "Adopter").

In consideration of receipt of the horse named \_\_\_\_\_ a (state color and breed and sex) \_\_\_\_\_ and in further consideration of the sum of (state amount) \_\_\_\_\_ (hereinafter "Adoption Fee") the undersigned agrees to the following "Terms of Adoption".

1. TRIAL PERIOD: Shamrock Farm, LLC and Adopter agree to a trial period of 30 days. This period may be extended, in writing, by mutual agreement of the parties. Adopter is responsible for any and all expenses (including veterinary and hoof care) required during the trial. Any expenses incurred by Adopter during the trial are non-refundable. Transportation of the horse to the trial location or back to Shamrock Farm LLC is at the expenses of Adopter. At or before the end of the designated trial period, Adopter may return the horse, (state horses name \_\_\_\_\_), to Shamrock Farm LLC, and the adoption fee will be refunded. Expenses incurred by the adopter will not be refunded. If adopter intends to return said horse to Shamrock Farm, LLC, Adopter shall notify Shamrock Farm by the last day of the trial period. Following the trial period, no refund of the adoption fee will be available.

2. TRANSFER OF OWNERSHIP: The intent of Shamrock Farm, LLC's contractual requirements regarding transfer of said horse, (state horse's name), is to protect the long-term well-being of the horse. The contractual requirements are not intended to unreasonably prevent a change of ownership.

Adopter may transfer ownership of said horse to a new owner through the following process:

Adopter must notify Shamrock Farm, in writing, of intent to transfer ownership of the Horse. This notification must include a detailed statement of why they are intend to re-home said horse.

Adopter may list the Horse as available for sale in the venues of Adopter's choice.

Adopter must fully disclose history of horse, including behavior problems and/or injuries, to prospective owners. Adopter must also notify all prospective owners of the requirement for the new owner to sign an adoption contract with Shamrock Farm LLC.

The intention of this agreement is to insure the continued good health and well-being of a horse named (include name) for the remainder of his life. It is the understanding of Shamrock Farm, LLC that the above mentioned person will do the most in their power to continue to create a living circumstance that is in the best interest of the (state horse's name and breed). This includes providing and maintaining a good standard of equine care including food, shelter and veterinary care.

If for any reason, (state horse's name), is or becomes, unfit or unacceptable to the above named adopter, he will be returned to Shamrock Farm, LLC, immediately.

It is also agreed that the above mentioned person will maintain contact with Shamrock Farm LLC or their agent on a yearly basis advising them of said horse's condition and whereabouts, including address and phone number of boarding facility or farm in which the subject horse is stabled. This will also include pictures of said horse along with a report on their activities. This may be mailed or emailed to Shamrock Farm LLC or their agent at the approximate anniversary of his re-location.

It is agreed by the signatories that the intention is to insure said horse has a loving, caring home and humane treatment is maintained throughout his life.

The re-homing fee of \_\_\_\_\_ (state agreed upon re-homing fee) will be accepted by Shamrock Farm LLC as a good faith consideration for this contract between the above mentioned parties.
